

## 99 speed Mart Promo Free RM10.00 Credit Promotion Terms and Conditions

1. This “99 Speed Mart Promo – FREE RM10 Credit” promotion (“**Promotion**”) is jointly organised by U Mobile Sdn Bhd (199101013657 (223969-U)) (“**U Mobile**”) and 99 Speedmart Sdn Bhd (519537-X) (“**99 Speedmart**”), and commences at 00:00:00 on 20 November 2019 and ends at 23:59:59 on 19 May 2020 (“**Promotion Period**”).
2. All entries received outside the Promotion Period will be automatically disqualified.
3. By participating in this Promotion, you agree to be bound by all the terms and conditions below (“**Terms and Conditions**”).
4. Promotion Eligibility
  - a. This Promotion is open to members of the public with a valid NRIC or passport.
  - b. U Mobile reserves the right to reject any entries or disqualify any participant without assigning any reason.
5. Promotion Mechanics
  - a. To participate in this Promotion, you must:
    - i. Purchase an Unlimited FUNZ Prepaid starter pack from any 99 Speed Mart stores nationwide as listed on <http://www.99speedmart.com.my/Store>;
    - ii. Perform a Prepaid reload of RM10, RM30, RM50 or RM100 (“**Reload**”) by the end of the next day (from the day you purchase the Unlimited FUNZ Prepaid starter pack), and if your account is Active (“Active” means able to make and receive calls) you are entitled to airtime credit of RM5; and
    - iii. If you subscribe to the GX30 plan by the end of the next day (from the day you purchase the Unlimited FUNZ Prepaid starter pack) and if your account is Active, you are entitled to additional airtime credit of RM5. ( collectively “**Free Credit**”).

*(Example: If you buy the Unlimited FUNZ Prepaid starter pack on 15 November 2019, you must perform the Reload and subscribe to GX30 plan by 11.59 p.m on 16 November 2019 in order to be eligible for the Promotion).*

6. Reward
  - a. The Free Credit:
    - i. may be provided by U Mobile only after you have performed the Reload and the subscription of GX30 plan;
    - ii. is valid for a period of 5 days from the date U Mobile credits the Free Credit into your Prepaid account (“**Validity Period**”);
    - iii. can only be utilised domestically (within Malaysia only). You will not be able to utilise the Free Credit for IDD calls, SMS or internet while you are roaming overseas. You will be charged based on the roaming rates imposed by U Mobile’s roaming operators for roaming usage; and
    - iv. is non-transferable and is non-redeemable for cash in full or in part.
  - b. Upon expiry of the Validity Period, any unutilised balance of the Free Credit will be automatically forfeited.

## 7. General

- a. U Mobile's decisions on any matter relating to this Promotion are final and binding on all participants. If any matters arise which are not covered in these Terms and Conditions, they will be determined solely by U Mobile.
- b. U Mobile may change any of these Terms and Conditions, including terminating or suspending this Promotion and extending the Promotion Period. Any such change will be announced on our website. It is your responsibility to check these Terms and Conditions on our website and if you do not agree to any of the changes, you must immediately cease participation in the Promotion.
